We may generate qualified interest income and short-term capital gains that may be exempt from United States withholding tax when distributed to foreign accounts. The percentage of 2020 income estimated to date as qualified interest income for tax purposes is 81.0%.

The final determination of the amount and source of 2020 distributions will be made after the end of our fiscal year and will be reported to stockholders on Form 1099-DIV.
